### ***Mission and Vision Board Scope of Responsibilities***

The Mission and Vision Board shall provide oversight, to ensure that all ministries of the congregation conform to the congregation's mission and vision. They will see that the Senior Pastor establishes a ministry structure that will carry out the mission of the congregation;

The Mission and Vision Board shall have the authority which has been conferred upon them by the Voters' Assembly, and whatever powers may have been delegated to them shall at all times be subject to change or revision by the Voters' Assembly;

The Mission and Vision Board shall consider and report all business matters pertaining to the congregation, directing a program of suggestions and recommendations for the Voters' Assemblies.

The Mission and Vision Board shall conduct meetings, as needed, for the oversight of the mission and vision of the congregation between the regularly scheduled meetings of the Voters' Assemblies, subject to the authority granted it by the voting body;

The Mission and Vision Board shall approve the annual budget submitted by the Senior Pastor in consultation with the Operational Council for study by the congregation not later than 30 days prior to the meeting for its adoption by the Voters' Assembly. Copies will be made available to members.

### ***Mission and Vision Board Qualifications***

- Regularly participate in the worship and educational life of the congregation.
- Undertake personal spiritual disciplines for the development of their own faith lives.
- Are good communicators
- Are visionary
- Can effectively represent the concerns of the "Owners (Servants, Stewards)" of the congregation.
- Have had sufficient years experience in the ministry of the congregation or in another congregation.
- Understand and support the basic concepts of Policy Based Governance.
- Are willing and able to support the Core Values of the congregation
